Where you are making a **posthumous application**, please note this checklist applies to the person who would have been, before death, entitled to victims' payments.

NB: There may be an assessment by a Health Care Professional during the application process to determine the degree of disablement. For applicants to be eligible for victims' payments, the assessed degree of disablement must be not less than 14%.

Terminology Explained

Posthumous application

An application can be made on behalf of someone who would have been eligible to apply to the Scheme but who has passed away on or after 23 December 2004. An application can be made by the deceased's spouse, civil partner, cohabiting partner or carer.

Present in "immediate aftermath" of a Troubles-related incident

Immediate aftermath includes any time when your loved one was in the same condition they would have been in at the scene of the Troubles-related incident. Click here for Victims' Payments Board Guidance on "Presence at a Troubles-related Incident or Immediate Aftermath".

Loved one

This requires a close relationship of love and affection. This is presumed for spouses; civil partners; people who live together as if married or civil partners; and a parent and child. Other cases are not presumed but may, for instance, include siblings, a grandparent/grandchild.

Other important factors to think about

Past-Compensation and Other Payments

When deciding upon a case, the Victims' Payments Board panel must look at any **past compensation** and/or **other payments** (or similar) for the same disability (for example Injury on Duty Pensions). **State benefits for disability (e.g. DLA, PIP) are** <u>not </u>**taken into account.**

If you have a past compensation payment or a relevant pension or similar payment you should **still consider applying** to the Scheme, but keep in mind that your payment may or may not be adjusted once the Regulations are applied to your case.

Past Convictions or Exceptional Circumstances

Under regulation 6, a person is not entitled to victims' payments in respect of a Troubles-related incident if:

- (a) the victim has a conviction (whether spent or not) in respect of conduct which caused, wholly or in part, that incident; or
- (b) the Board considers the person's "relevant conviction" makes entitlement inappropriate.

Panels may also consider exceptional circumstances that may make entitlement inappropriate e.g. involvement in recent terrorist activity.
